### **RX D**irector's Message

RX Update by Director, Dr. Kathy Stevens

Dear Colleagues and Alumni of RX, Hello! It's been a busy and eventful winter and spring. I'll briefly describe just a few of the noteworthy events since the last newsletter.



October 2009 found RX hosting the Scientific Advisory Board for its biennial visit. Through briefings, tours, and posters, the panel saw the

RX work in thermal sciences & materials, electromagnetic materials integration, optical and infrared materials, RF and electronic materials, materials biotechnology, and nanomaterials. They were both impressed that RX reacts to the changing environment and changing AF needs and funding realities (as evidenced by the creation and elimination of several sub core technical competencies since the last review) and the sustained 25+ year development of rugate filter technology and the applications it's enabling today. Overall, the panel was impressed with many of "RX's impressive technical teams" and believes that RX continues to be a highly valued resource within the DoD and the wider scientific community.

October also saw the AFMC Commander, General Hoffman, visiting Tyndall AFB to tour RXQ facilities and hear about the exciting work going on there in blast protection, advanced runway materials and processes, deployed energy, biotechnology, and robotics. Like the AFMC Vice Commander, who had visited earlier in the year, he was quite impressed with the caliber and relevance of the work going on at RXQ in airbase technologies.

November saw the Defense Manufacturing Conference, a well-attended forum for the defense manufacturing enterprise, and further interaction of RXM with Industry and Government on a new Air Force Manufacturing Technology Program Strategic Plan, a roadmap to 2025 and an agile, next generation manufacturing industrial base. The Plan defines the technology underpinnings of a new 21st century industrial base vision and maps key transformational pathways to enable its proactive attainment. The approved and coordinated final version of the plan will be published this summer.

With the New Year, many of you were able to join us as we celebrated the accomplishments of RX folks with the annual Materials and Manufacturing Directorate Awards luncheon. I'm sure you were amazed as I was at the diversity of the accomplishments represented by the RX awards finalists and their impact on the Air Force. Outstanding work from so many truly talented dedicated people!

February was a very busy month. We welcomed the new AFRL Commander, Maj Gen Ellen Pawlikowski, and a new SAF/AQR, Dr Steve Walker. Both are alumni of AFRL predecessor laboratories and both are dedicated to working together to make AFRL and the Air Force S&T portfolio as leading-edge and relevant as possible,

### **PRESIDENT'S CORNER**

In our last edition of the newsletter, I described a meeting we had with Dr. Stevens in which we discussed how the Alumni Association might best support the Materials & Manufacturing Directorate in the coming year(s). One of the ideas that was discussed, which now seems to be gaining quite a bit of momentum, is for the Alumni Association to partner with the Directorate to identify and describe the most noteworthy contributions of RX (ML) to the AF over the past few decades.

The role of the Association would be to help identify the most noteworthy contributions, help tell the real story behind how those developments happened and the resulting impact to the AF (and in some cases the nation), and assist in developing displays throughout the RX complex that tell the story.

Several of the Association officers have met, joined by George Schmitt, RX liaison to the Association, to put together a rationale for the importance of this initiative and a strategy for how we might proceed. We subsequently met with Dr. Stevens and discussed the following information with her for her consideration: *(Continued on Page 2)*

and to ensure that it is understood and valued by senior Air Force leadership. Both are actively engaged with AF senior leadership and the AF corporate structure and on the development of an Air Force Science & Technology Strategy. General Pawlikowski also moved out quickly to review the entire AFRL Future Long Term Challenge portfolio and to begin to identify which capability concepts might be considered "Flagship Capability Concepts." She also kicked off an Associate Director-led MAJCOM Engagement process to better link MAJCOM needs with AFRL technology development.

In February, we also kicked off a Grey Beard Study on Sustainment Technology. Jointly sponsored with AFMC/A4 and AFMC/A2/5, the study was commissioned to identify what is needed to improve the process of moving technology capability from AFRL to the Sustainment Community. The Panel, which included our own illustrious alumnus Dr Vince Russo, briefed its well-received findings and recommendations to study sponsors earlier this month.

In March, we kicked off an RX Investment Review. Designed to facilitate RX's future technical and organizational strategy, enable informed resource priorities and decisions, and guide RX responses to AFRL corporate planning and programming, the review has required significant investments of time from the entire directorate. The review will be completed in June and the results briefed to the directorate in July.

In this newsletter and in coming months, you will hear more about an RX (or as most of you remember, an ML) history initiative. Please help, if you can, and, as always, please keep in touch.

#### **Situation**:

- It is critical for RX to tell the story of how it and its predecessor organizations have made major contributions to warfighting capabilities in the AF. In telling this story, RX can ensure that its customers/ stakeholders appreciate the important role of RX to:
  - -- The corporate AF
  - -- Other AFRL partners who need RX products to achieve their objectives
  - -- RX visitors
  - -- New members of the RX (ML) family

- Concise, hard hitting descriptions of those major contributions must be preserved and used appropriately to reinforce how current capabilities would not exist without the contributions of the men and women of the Directorate over many years.
- Without a dedicated effort to keep these contribution stories alive and available, they are easily missed or lost entirely.
- Displays throughout the RX complex, coupled with documented vignettes for use in briefings and other publications would be a valuable asset in telling, in a compelling way, the major contribution story but it is essentially non-existent at present.
- When a visitor comes to the 65X complex, there are limited displays to communicate the "feeling" that they are in the "Materials & Manufacturing Center" for the AF with a proud tradition and contributions to the AF over the years.
- Many artifacts and documents with historical significance have been lost over the years, and continue to be lost, because of a lack of focus on retention and display of these items.

#### Proposal:

- Gain Exec Group agreement/commitment to launch and support the initiative to identify, describe and display these significant contributions – in order to create an unmistakable feeling that when you are in the B65X Complex, you are in the Materials & Manufacturing "Central" for the AF.
- Create "the primary list" that represents the most notable contributions that deserve display status. This list will be developed from inputs from:
  - -- Each Division
  - -- Alumni (including past Directors)
  - -- Long-standing Industry Partners
  - -- Others?
- Search for/acquire hardware, documentation and historical pictures of these major advances.
- Develop displays (display walls) throughout the 65X complex to tell the story including the B653 Lobby.
- Develop short vignettes of these advances for use in briefings and updates to RX and AFRL history documents, and posting to the AFMMAA Web-Site.

- Consider this initiative as supportive of a major theme for the 100th Anniversary, which will occur in 7 years.
- Stop the loss of items of significant historical value by preserving and protecting current assets and ensuring that, as people retire or leave RX, there is a specific focus placed on identifying and retaining important items with historical value.

Dr. Stevens's reaction to this proposal was very enthusiastic. She has begun to discuss this proposal with the RX Executive Group, and plans to meet with us again to finalize the way forward. We hope to be able to discuss these plans with you in subsequent newsletters and at the upcoming Membership meeting at the Engineers Club in June. To successfully accomplish this most important effort, we will need the help of a broad cross-section of the alumni, and I hope you will consider making yourselves available to help preserve the legacy that you helped create.

# THE LATEST ON J8DED AND "BASICALLY BRIISH

As described in the last couple of issues of the AFMMAA Newsletter, Terry Ronald is involved with a TV series that is being filmed in the Dayton/Cincinnati area. The drama/comedy has just wrapped up the filming of a number of episodes that should be available for viewing this summer. Currently in post-production, the series revolves around the adventures of a pop-singing husband and wife duo called J8DED. Having been forced to leave a hugely successful career in Britain-for reasons that become apparent in season one of the series-the singers are trying to make a name for themselves in the US, starting in their new home of Cincinnati. Fortunately, they have the help of their manager, Terry Copeland (aka Terry Ronald), who comes to the US and starts a shop and tea room called Basically British in Dayton in order to make money to fund their new career in the US, where they are presently totally unknown. There is much humor involved in the activities of the duo, along with their manager and other characters as they attempt to regain some of their former renown, even though reduced to playing in local establishments not known for their glamour.

As the series progresses, it becomes apparent that there is much more to the story than is evident from

the humorous side of it. Many of the characters are not necessarily what they seem at first, and Terry Copeland himself is clearly much more than a shopkeeper—the term "Rogue Agent" has been used to describe him, for he has a history of being involved in questionable activities in his former role as a member of Her Majesty's élite special forces, and seemingly is still involved in related goings-on in some way. Reflecting the "Drama" aspect of "Drama/Comedy," the series incorporates much military action and deadly activities, yet this very serious stuff is intermixed occasionally with quirky humor.

Although Terry has been involved since the start of production a couple of years ago, he has discovered that this does not necessarily mean he knows all there is to know about the finished story line. The nature of filming is such that he turns up for scenes he is in but they are not done in sequence, so there many scenes he has not yet seen, or has not seen linked together in a meaningful sequence. He will be as interested as anyone else to see the final product. The series has been picked up by Proctor and Gamble and should be available nationally somewhere sometime soon. ### Spring 2010 Scholarship Update

The call for applications for the 2010 AFMMAA Scholarships is now out on the AFMMAA website and also on the AFRL/RX Intranet. The deadline for receipt of applications is 14 May 2010. This year we anticipate the award of two \$1000 scholarships to highly qualified students planning to enter their first or second year of college. The students must be children of a current AFRL/ RX government (civilian or military) employee.

The results of the 2009 scholarship awards were reported in the Fall 2009 AFMMAA Newsletter. To recap those results, we received four applications last year of which we were able to fund three 2009 scholarships of \$1,000 each. The three students were Shuvro Roy, Julia Sizek, and Grace Stearns. Shuvro is enrolled in the Ohio State University Honors Program and is pursuing the OSU Early Admission Pathway Program to become a medical doctor. Julia is attending the University of Chicago and is planning to pursue a degree in Chemistry or Environmental Policy. Grace is another of our homeschooled scholarship recipients. She is pursuing a Chemistry degree at Cedarville University and then plans to study toward an advanced degree in veterinary-related research. Recognition was given to those awardees at an August 2009 AFRL/RX Director's Call. They were again recognized at the RX Awards Luncheon held at the Hope Hotel in January 2010.

The AFMMAA has established a merit scholarship program for the purpose of assisting high achievement, educationally oriented sons and daughters of the current AFRL/RX civilian and military workforce. ## **AFMMAA HISTORY**

In 2000, Tom Cooper, Bob Rice, other AFRL/ML retirees, and ML personnel began planning actions that eventually led to the creation of the Air Force Materials and Manufacturing Alumni Association (AFMMAA). On 18 December 2000 the AFRL/ML Executive Group approved the formation of the AFMMAA. The new "Association" soon drafted its Charter, refined its goals and objectives, and developed a member mailing/contact list. Initial funding to support expenses and scholarship

plans for the new organization came from the Charter Memberships of 12 individuals who were deeply involved in its planning and the contributions from AFRL/ ML personnel. No government funds were involved.

The 1st official business of the AFMMAA began with an organizational meeting that was held on Friday, 22 June 2001, which was the day of the Materials and Manufacturing Directorate Annual Awards Luncheon in 2001. The organizational meeting was held at Universal Technology Corporation in Beavercreek from 9:00 until 10:30 AM. Approximately twenty people were in attendance at the meeting. The sentiment was strong that an alumni organization could do many "good deeds" in support of the Materials and Manufacturing Directorate. During the meeting, an organizing committee was established to seek volunteers to be the first officers of the organization, finalize the by-laws, and establish membership criteria and categories, along with a dues The organizing committee subsequently structure. identified the five individuals who graciously volunteered to serve for the first two years. They were: Mr. Phil Bouchard - President; Mr. Tom Cooper - Executive Vice President; Mr. John Williamson - Vice President for Membership; Mr. Jerry Kelble - Treasurer; and Mr. Bob Rice - Secretary. There were a host of other tasks that were also identified by the steering committee, which included planning a Newsletter, designing and selling logo items, developing a scholarship program, and planning some activities in conjunction with the current workforce. A number of other critical activities were subsequently identified and carried out, including preparing a Charter, filing to become a 501C3 tax-free organization, arranging to get a bulk mailing permit, preparing a list of addresses of former and current AF personnel to contact to invite to become members, and a number of other important activities that eventually led to the future success of the AFMMAA.

Today the AFMMAA has a mailing list of approximately 300 alumni. In addition to its 12 Charter Members, 46 alumni have become Life Members and approximately 80 members pay yearly dues. A list of AFMMAA accomplishments may be found in below. Perhaps, its most significant accomplishment is the AFMMAA has granted 17 academic college scholarships totaling \$16,000 to deserving children of the AFRL/ RX civilian government and military workforce.

### **AFMMAA HOLDS MEMBERSHIP MEETING**

The 2010 Annual Meeting of the AFMMAA was held on the morning of 22 January 2010 at the Hope Hotel, WPAFB, immediately preceeding the "Materials Lab" Annual Awards Luncheon. Twenty-one members (see photograph) attended the meeting. Mr. Gary Waggoner, President, conducted the meeting and welcomed the opportunity to continue the great legacy that the AFMMAA has established. He reported that the Executive Board had a very satisfying and beneficial meeting with Dr. Kathy Stevens, the AFRL/RX Director, on 29 July 2009. Discussion at their meeting resulted in a couple of potential initiatives for AFMMAA to consider, such as a mentoring program for young S&Es and a project that would capture and display throughout the Building 65X Complex the contributions and heritage of the Lab. It was decided that the AFMMAA would continue to consider these and other such options and develop one or more initiatives to support the Lab over the coming year. Secretary Dick Engman reported that the minutes of the 4 June 2009 meeting were posted on the AFMMAA Web

Site. Treasurer Dennis Naughton presented the CY 2009 Financial Report having a year end balance of \$5,709. Scholarship Award Chairman Bob Cochoy reported that four applications were received in 2009 resulting in three scholarship awards of \$1000 being granted. The revised Charter incorporating all amendments will be prepared and distributed to members for review at least 30 days prior to the June 2010 Meeting.
