

AIR FORCE MATERIALS AND MANUFACTURING ALUMNI ASSOCIATION SCHOLARSHIP

DESCRIPTION

AFMMAA established this merit scholarship program for the purpose of providing financial assistance to academically high-achieving children and grandchildren of current AFRL/RX government employees and military members (“AFRL/RX,” in this document refers to AFRL/RX as well as its predecessor or successor organizations).

ELIGIBILITY

Any natural or adopted child or grandchild of a current AFRL/RX government employee (civilian or military) is eligible to apply for a scholarship. The primary focus of this award is to assist recent high school graduates about to enter their first year of an accredited two- or four-year college or university program. The general requirements listed below will be used to guide the award selection process.

APPLICATION REQUIREMENTS

(See *Scholarship Application* for specific details)

- Submission of an essay that describes personal educational goals and career aspirations.
- Submission of two academic/character letters of recommendation.
- Evidence of academic achievement, as measured by grades, test scores and special recognition/awards, including:
 - A high school transcript providing evidence of pending graduation with a minimum unweighted GPA of at least 3.0 on a scale of 4.0.
 - Standardized test score (e.g., ACT and/or SAT) report(s)
- Examples of involvement in extracurricular activities and/or community service.
- Statement of intent to follow an approved course of study that will lead ultimately to an academic degree or equivalent on its completion, including an indication of intended career goals beyond college.

In addition to providing information addressing these requirements, it is important to note that all applicants must show evidence of acceptance as a full-time student (to be enrolled in the equivalent of at least 12 semester credit hours) in an accredited two- or four-year college or university.

SELECTION PROCESS

Applicant submissions will be evaluated by a selection committee chaired by an AFMMAA member named by the Executive Board. The selection committee chair will identify remaining committee members, who will also be members of the AFMMAA and whose collective experience (including that as a prior employee of AFRL/RX) will generally be representative of the technical, organizational and functional diversity of AFRL/RX.

Using the evaluation requirements listed above, the selection committee will review the submitted applications and select those it judges to be qualified for a scholarship award. The selected applications will be listed in priority order of assessed merit, as determined by a vote of the committee members, and the list submitted to the Executive Board for its consideration. The Executive Board will make the final selection of recipients, based on the selection committee's recommendations and the availability of funds.

There are many factors involved in the selection process conducted by the committee, but as a starting point, each member independently reviews each application and scores it using a points system that encompasses the five award requirements. These scores are used as a framework to guide the subsequent committee discussions that in turn leads to the choosing and ranking of the submissions considered to have met the requirements.

As an indicator of the committee's view of the relative importance of the requirements, the maximum score assigned to each is as follows:

- Essay 30
- Character/academic references 25
- Academic performance evidence 25
- Extracurricular activities 15
- Interest and intent beyond degree 5

AWARD PROCESS

The AFMMAA Board, on behalf of the Association, will inform the applicants of the results of the evaluation. Scholarship financial awards to successful applicants will be made directly to the academic institution that the recipient will be attending, and are intended to be applied to tuition fees and general fees that the recipient will be incurring.

The board may later give formal recognition of the awards at a suitable AFRL/RX event (e.g., a Director's Call or the annual Directorate Awards Ceremony), and the names of awardees and their photographs may be published on the AFMMAA web site, as well as in any appropriate AFRL/RX publications.

Depending on the availability of funds, scholarships in the amount of up to \$1000 may be awarded, typically in August. Any award won, but unclaimed by the end of the calendar year indicated as the basis for the award application, is subject to forfeiture.

APPLICATION FORM

Applicants must complete a **Scholarship Program Application**.
