### PRESIDENT'S CORNER

Greetings to all the members and friends of the Alumni Association!

It appears that our proposed initiative to help the Materials and Manufacturing Directorate identify and document/display the most noteworthy contributions to the AF over the past few decades is finally picking up speed.

At our January membership meeting, held in conjunction with the Annual RX Awards Luncheon, we reported that the small subcontract that RX awarded to Universal Technology Corporation (UTC) last fall had produced significant results. In that short three month effort, led by Warren Johnson and supported by several alumni who also work for UTC, the following was accomplished:

- AFMMAA members were queried for additional significant contributions to augment the list that we communicated to you in the Fall Newsletter. This request also solicited detailed information on contributions from the personal files of alumni members I want to personally thank all of you who responded to this request.
- The list of significant contribution areas as reported in the fall newsletter was expanded to over 75 areas.
- The data base of information at UTC was searched for applicable information against the list of 75 and a number of project files were assembled that contained background information, R&D objectives, achievements and payoff to the AF.
- AFMMAA members who were involved in each technology area were identified as potential participants in documenting the R&D effort and resulting contributions.
- The UTC team visited the Propulsion Directorate (AFRL/RZ) to observe the historical contribution displays in Building 18 foyer and hallways.
- Several 75th anniversary documents & the 75th CD were reviewed, and
- An approach was conceptualized for the hallway wall displays in the Building 65X complex using several landmark technologies, as examples.

In January we had a short meeting with Dr. Stevens in which we showed her the growing list of contributions, provided her with a summary of the above accomplishments as well as examples of products from the effort. Dr. Stevens encouraged the AFMMAA to continue to develop the approach, and specifically requested that we find a way to organize the many contributions into major themes in support of the limited number of displays that will be possible in the complex.

Subsequently, George Schmitt, who is our AFMMAA representative in RX, took the detailed list of contributions and showed how it could be organized into major themes appropriate for displays in each division of RX.

Using this product, we met several times in February and March to develop an approach to the displays, as follows:

Lobby – show the directorate's most important contributions to key AF Sectors:

- Air
- Propulsion
- Space
- Sustainment
- Electronics
- Missiles
- Munitions

Divisions/Branches – display the most important division/branch contributions organized by decade. These would involve a broader number of significant technologies and be comprised of displays would be tailored by each branch/division:

- Descriptions of the contributions & significance
- Pictures
- Samples
- Key people (where appropriate)

We also proposed adding a set of displays outside the the Corporate Development Office (RXN) to recognize the important efforts in Leadership and Organizational Development, several Management Initiatives that proved vital to the lab and the key tenets of RX that have been developed and endured over the years.

In late March, we again met with Dr. Stevens to review this concept and propose an approach to move forward.

Dr Stevens then asked for us to provide her with a Statement of Work for a follow-on contractual effort to support this initiative and prepare to meet with the RX Executive Group in early June to launch this initiative. We hope to do this just prior to our semi-annual meeting (Dayton Engineers Club – 16 June).

As part of our discussions with Dr. Stevens, Tobey Cordell proposed that the Alumni Association help RX honor Astronaut Dr. Cady Coleman, an RX alumni now serving on board the International Space Station. Please see the article in this newsletter on what has been done in this regard.

So this is where we now stand. The SOW has been delivered to RX and we are awaiting word of its acceptance and the date of our engagement with the Executive Group. We will give everyone an update on the initiative at the June meeting. I'm looking forward to seeing all of you there!

The AFMMAA held its bi-annual members meeting on January 14, 2011 at the Hope Hotel prior to the Annual RX Awards Ceremony. Twenty alumni and AFMMAA friends braved the winter weather. Warren Johnson discussed "Major Historical RX Contributions" the short term, initial contract work recently performed by Universal Technology Corporation. This work is in support of an AFMMAA initiative to identify and document the most noteworthy contributions of RX (ML) to the Air Force over the past few decades. The AFMMAA goal is to preserve the real story behind the important advancements and make these contributions visible to all visitors to RX. The AFMMAA is working with Dr. Stevens to continue this effort and possible planning for the RX(ML) 100th Anniversary Celebration in 2017.

The following provides brief highlights of the Board and Chairman Reports. Detailed minutes are posted on the AFMMAA web site. Jerry Petrak, Nominating Committee Chairman, is working to replace Dick Engman (Secretary) and Tom Cooper (Newsletter). The other board members have agreed to continue for another term. Dr. Charles Browning will be the new Scholarship Chairman. Thank you Dr. Bob Cochoy for your past work to make the scholarship program so successful (also see the Scholarship article). The Treasurer reported the CY 2010 financial status. The Dec 31, 2010 balance was \$6,755.38. Since 2007 our scholarship funding has received a total of \$4,617.99 from CFC, \$983.76 from United Way. Life Memberships continue to be very important for our scholarships and membership dues are critical for our operating expenses. John Williamson prepared the 2010 Annual Report which will be submitted to the Combined Federal Campaign for our 2011 membership renewal. Members and RX employees are making excellent CFC pledges to the AFMMAA which enables us to continue and possibly expand our yearly scholarships. The AFMMAA CFC Code is 85464. Tom Cooper reported the Fall Newsletter, the 13th Edition, was mailed on 4 Jan 2011. It was another superb job. However, Tom has expressed his desire to "retire" and a new Editor is needed. Please contact Tom or Jerry Petrak if you are interested. Tom has been the driving force behind the Newsletter since its inception. John Williamson reported the AFMMAA monthly luncheon get-togethers have been very successful with approximately 6 to 12 alumni attending each month. # Astronaut Cady Coleman

currently on the International Space Station as a crew member of Expedition 27

Nonmetallic Materials Division Officer and Chemist 1988 to 1992

As a research chemist at the **Materials Directorate of Wright** Laboratory, Coleman synthesized model compounds for a wide variety of advanced optical applications, completed her PhD in polymer science and engineering, and served as a surface analysis consultant evaluating the effects of the space environment on new materials being evaluated on the Long Duration Exposure Facility (launched from STS-41C in 1984 and retrieved during STS-32 in 1990). In addition to her assigned duties, Coleman was a volunteer test subject for the centrifuge program at the Armstrong Laboratory where she set several endurance and tolerance records.

Dr. Coleman was selected by NASA to the Astronaut Corps in March 1992. She has served in numerous capacities including: special assistant to the Johnson Space Center Director; lead astronaut for long term space habitability issues; CAPCOM in mission control for both the space shuttle and space station; and chief of astronaut robotics training

She is a veteran of two space missions and prior to her current mission, had logged more than 500 hours in space.

### Fellow Materials & Manufacturing Directorate Alumna and Astronaut Dr. Cady Coleman is Flying High These Days

She is currently a member of the Expedition 26 flight crew on board the International Space Station (ISS). Cady, who left the lab to join the astronaut corps in 1992 is a veteran of two space missions, and prior to her current mission has logged more than 500 hours in space.

She was a mission specialist on STS-73 Columbia (October 20 to November 5, 1995) – which was the second United States Microgravity Laboratory mission. This mission focused on materials science, biotechnology, combustion science, the physics of fluids, and numerous scientific experiments housed in the pressurized Spacelab module. Cady's second mission was as the lead mission specialist on STS-93 Columbia (July 22-27, 1999) for the deployment of the Chandra X-Ray Observatory. In preparation for her Expedition 26 mission, Cady underwent extensive training for this long duration flight and served as the backup U.S. crewmember for Expeditions 19, 20 and 21 and as a backup crewmember for Expeditions 24 and 25.

On Expedition 26, Cady, along with fellow flight engineers Paolo Nespoli of the European Space Agency and Cosmonaut Dmitry Kondratyev, launched to the ISS from the Baikonur Cosmodrome in Kazakhstan on December 15, 2010 aboard a Russian Soyuz spacecraft. Expedition 26 will last approximately 6 months with a planned landing sometime this spring, again aboard a Soyuz spacecraft.

Fellow alumnus Tobey Cordell learned of Cady's mission and suggested to Dr. Stevens that RX put up a display in the lobby of B653 to honor this achievement. The poster shown with this article (previous page) is a result of Tobey's efforts, along with excellent support from RX Executive Officer Lt. Dave Fortson and RX staff members Lori Brown and Tim Anderl. It is now on display in the lobby. In addition, the lobby has a bank of video monitors that feature various accomplishments from RX R&D programs. Several videos of Cady in orbit are being shown over the next several months. If you are interested in seeing the three videos that are currently playing, go to http://www.nasa.gov/mission\_pages/station/main/index.html.

On the top menu bar, click on multimedia and go to the video link on the far left side of the page. You will then be connected to the NASA video webpage, and be able to view a wide variety of videos, including live links to the ISS. The video selections on the right side of the page are updated each day, so the locations change frequently. However, as of this writing, the three videos now playing in the RX lobby can be located as follows:

- Cady plays a flute duet with Ian Anderson, honoring Uri Gagarin 2 min. 24 sec, located on page 8.
- A St. Patrick's Day Message 4 min. 2 sec, located on page 9, and
- Flight Engineer Cady Coleman gives a ISS tour -- 8 min. 19 sec, located on page 10.

We think you will really enjoy these as well as others on the site.

So our heartiest congratulations to alumna Dr. Cady Coleman – all of us are proud of your contributions to the nation's space program.

### AIR FORCE MATERIALS AND MANUFACTURING ALUMNI ASSOCIATION (AFMMAA) MERIT SCHOLARSHIP PROGRAM

The AFMMAA has established a merit scholarship program for the purpose of assisting high achievement, educationally oriented sons and daughters of the current AFRL/RX civilian and military workforce. Scholarship winners and details of the Merit Scholarship Program and criteria are found below in the following pages.

Two types of merit scholarship are granted: Alumni Association Scholarship and Chief Scientist Scholarship. ### Spring 2011 Scolarship Update

The call for applications for the 2011 AFMMAA Scholarships was placed on the AFMMAA website and also on the AFRL/RX Intranet in mid-February 2011. For this year, we have broadened the eligibility criteria and simplified the application process. We no longer restrict the field of study of applicants to areas of direct relevance to RX. Applicants pursuing all four-year accredited degrees are now considered. Also, the requirement for three letters of recommendation as part of the application has been dropped. The deadline for receipt of applications was 14 May 2011.

We have received five applications for evaluation this year. The Scholarship Committee plans to meet in June to select this year's awardees. This year we again anticipate the award of at least two \$1000 scholarships to highly qualified students planning to enter their first or second year of college. The students must be children of a current AFRL/RX government (civilian or military) employee.

The results of the 2010 scholarship awards were reported in the Fall 2010 AFMMAA Newsletter. To recap those results, we were able to fund three 2010 scholarships of \$1,000 each. The three students were David Baumgartner, Erika Johnson, and Anastasia Voevodin (see page 6). David is enrolled in the Civil Engineering program at Rose-Hulman Institute of Technology. Erika is pursuing a degree in biology or neurobiology at the University of South Florida. Anastasia is attending Boston University pursuing a degree in Biomedical Engineering. Recognition was given to those awardees at an August 2010 AFRL/RX Director's Call. They were again recognized at the RX Awards Luncheon held at the Hope Hotel in January 2011.

### **AFMMAA** CHARTER UPDATE

Last year, the AFMMAA Charter was updated by Vice President John Williamson and Secretary Dick Engman. The original Charter was prepared by Tom Cooper and Bob Rice in 2001 and they fortunately had the foresight to establish a strong Charter which required only minor additions and a few revisions. It was officially approved by members at the June 23, 2010 meeting at the Engineers Club.
